Signed Waivers must be kept on file by the Facility Owner for a minimum of seven years. The Facility Owner must submit the signed waiver with the claim report.

**Field/facility owners additional insured status is now available for any USSSA sanctioned activity.**

**\$3,000,000 General Liability Per Occurrence**

This USSSA program provides the general liability coverage for bodily injury, property damage, and personal injury claims for which you are legally obligated. Only USSSA sanctioned activities in the insured sport(s) are covered.

Coverage is provided with a limit of \$3,000,000 per occurrence. Coverage is written on an occurrence form, not a claims made form. Also, this liability insurance is primary, not secondary.

The USSSA liability insurance program provides coverage for lawsuits brought by athletic participants. This coverage is crucial, and is excluded on many general liability policies written today.

EPIC Brokers and K&K Insurance Group, Inc. combine their many years of experience and excellent liability coverage to provide you with an insurance value that is second to none.

### **Full Season Coverage - \$1,550 Covers USSSA League and Tournament Play**

The cost of full season coverage is \$1,550 per insured for all sports, which includes an administration fee. The premium is fully earned upon certificate issuance. **Refunds are not available. All coverage expires on 01/01/19.**

### **Weekend Coverage - \$750**

Coverage may be written for one weekend (maximum of seven consecutive days) for \$750 per weekend, which includes an administration fee. The premium is fully earned upon certificate issuance. **Refunds or transfers to other dates are not available. No credit will be given from weekend coverage to full season coverage.**

*This is a brief description of the coverage. A disclosure of the definitions, exclusions, and limitations for this coverage can be found in the association policy issued to the USSSA. If any discrepancy exists between this description and the policy, the policy will prevail.*

### **Waiver Forms**

#### **ADULT SPORTS**

**All adult players are required to sign an approved Waiver and Release Form. The Approved Waiver and Release Form can be found on the USSSA Website [www.ussa.com](http://www.ussa.com).**

#### **YOUTH SPORTS**

USSSA strongly recommends the use of waiver forms for all youth athletic participants. All USSSA roster forms contain the recommended waiver wording. Parent Waivers can be found at [www.ussa.com](http://www.ussa.com). While waivers are recommended, coverage is not affected in the absence of a signed waiver.

### **Special Notes**

This additional insured status covers only the business entity during USSSA sanctioned activities. Teams or leagues must enroll for coverage under the team insurance program.

Notable policy exclusions include but are not limited to automobile liability, amusement devices, player vs. player, fireworks, concerts, bodily injury to employees, sale of alcohol.

This is a brief outline of policy coverages and exclusions.

### **Requirements for coverage to be in effect:**

1. All teams must be registered with USSSA.
2. All umpires/officials must be registered with USSSA.
3. Tournaments must be sanctioned with USSSA.
4. Coverage is in effect during USSSA sanctioned activities only.
5. Coverage begins upon receipt of the enrollment form and appropriate premium, and expires on 1/1/2019. You must apply for coverage each year.

**Tournament insurance is available to cover USSSA sanctioned tournaments.**
